- A. North Park Thursday Market: Brian Beevers
  - 1. Brian Beevers reported on the success of the new market layout, the launch of E.B.T., and gave a brief financial report.
- B. Police Report: Jenny Hall
  - 1. Jenny reported that she will follow up on the security alarm call issue for David Gamboa. She also reported a break in at Dunedin.
- C. State Senator Toni Atkins, District 49: Jason Weisz
  - 1. Jason reported that Toni is working with ABC to provide clarity on regulations and expressed willingness to facilitate meetings with business owners and ABC. He also reported that Toni has reintroduced two bills: a Mental Health Medical Bill, and a Historic Tax Credit bill. Additionally, he spoke on the States cap and trade money and discounted bills for businesses.
- D. Assembly Member Todd Gloria, District 78: Mathew Gordon
  - 1. Mathew Introduced himself to the group and spoke on events sponsored by Todd Gloria's office, a scholarship program, and business tour with NPMS. He encouraged attendees to reach out to him if needed.
- E. County Supervisor Nathan Fletcher, Fourth District: Brandon Torres
  - 1. Brandon reported on support for expansion of electric vehicle charging stations, the approval of a behavioral treatment center in Hillcrest, homeless programs, on upcoming events, and new services added to the North Park probation office.
- F. San Diego Council Member Chris Ward: Tyler Renner
  - 1. Tyler spoke on success in saving Skate World, issues with Civic San Diego, the Mayor's budget and expected 3% budget cut, Council approved homeless aid funds, the 30<sup>th</sup> Street bike lane and associated supporting events, and assisting NPMS with approval of North Park Wayfinding signage.
- G. City of San Diego, Economic Development Department: Alissa Gabriel
  - 1. Alissa spoke on BID budgets going to Committee.
- H. North Park Planning Committee: Tim Taylor
  - 1. Tim reported on the Planning Committee sharing a website with Uptown News, and NPPC election results.
- I. North Park Maintenance Assessment District (MAD): Angela Landsberg
  - 1. A report was given on City trash services, and the refurbishment of the Anne Mudge art project on University Avenue.

# B. 30<sup>th</sup> Street Bike Lane

1. A discussion was held on the revised, third option for the  $30^{th}$  Street bike lane. A graphic was presented showing that option. A meeting at the North Park Planning Committee to discuss the third option will be held on April  $16^{th}$ .

1. An update was given on the festival. It looks like NPMS will exceed its vendor and sponsorship goals. Angela Landsberg noted that costs for contractors are up this year.
