Adrian Granda reported that City Council approved budget adjustment – 4 million is going to aiding homeless veterans – goal to house 1,000 vets within a year – incentives for landlords to offer low-income housing. The Red Sidewalk Project is almost complete – \$300,000 to \$400,000 project

Homeless Issues: have been in the news in the past few weeks with the storm

- Increased complaints about unattended property, encroachments in the right-of-way
- Please make sure to respect civil rights do not take matters into your own hand
- Either report to the City Council office or the PD non-emergency line
- The more you call the non-emergency line, it will create a log of incidences
- If items are left unattended for 24 hours, they will be taken to a storage facility
